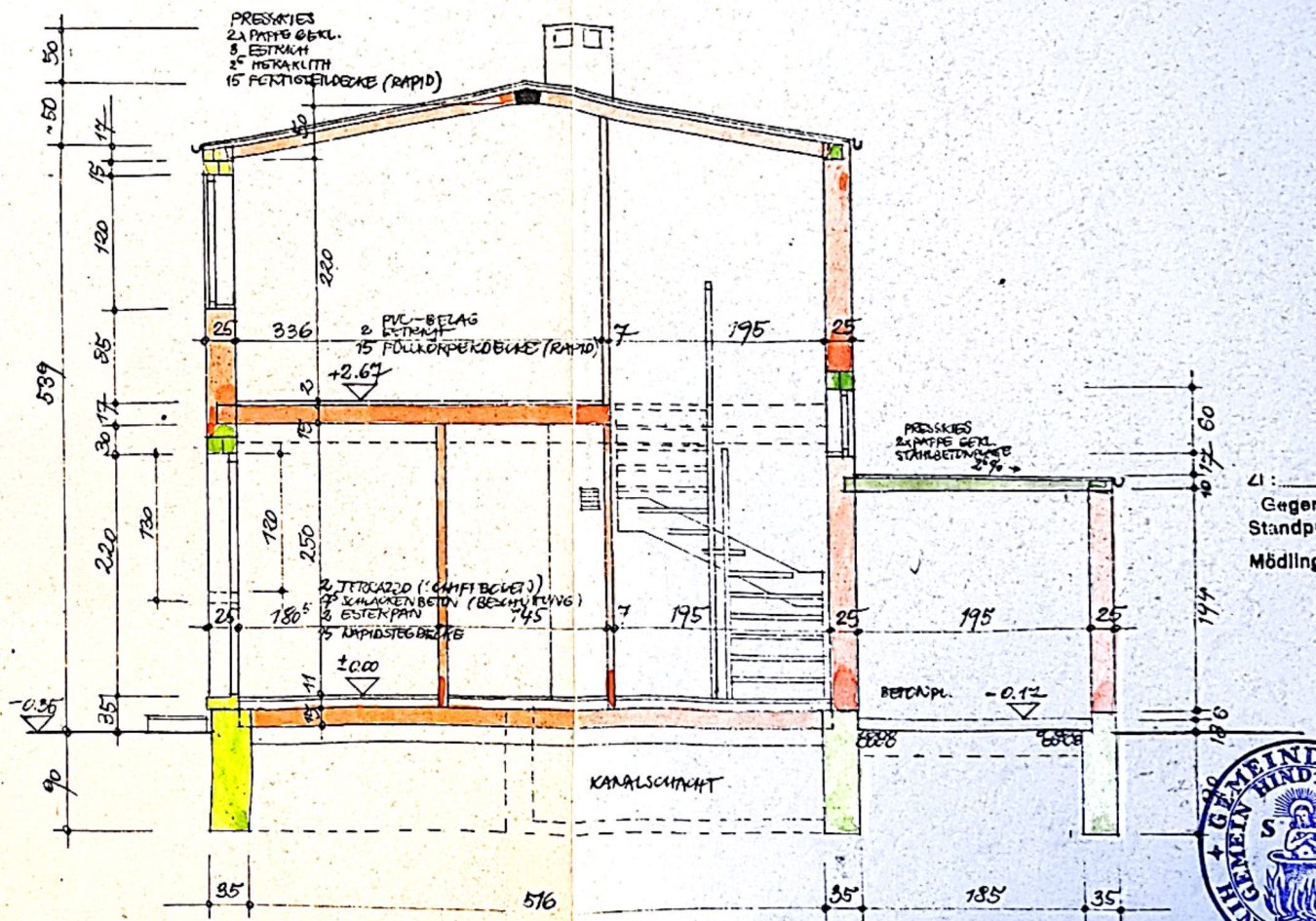

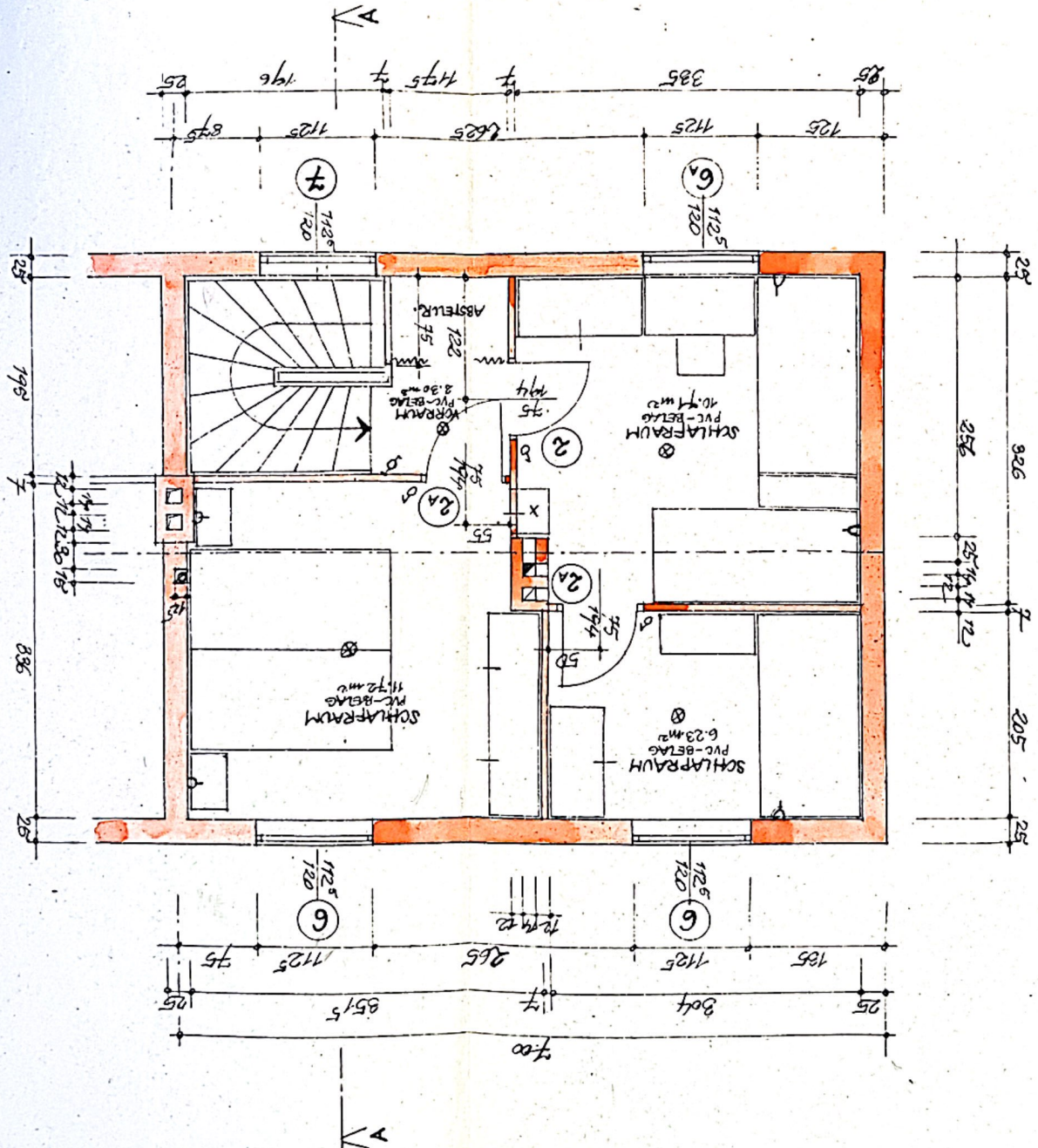

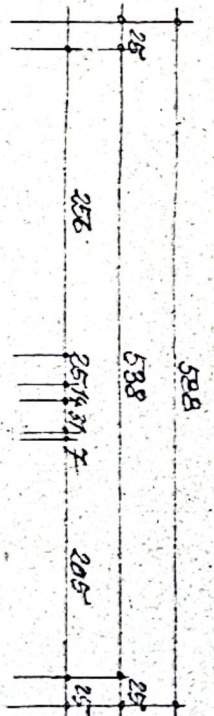


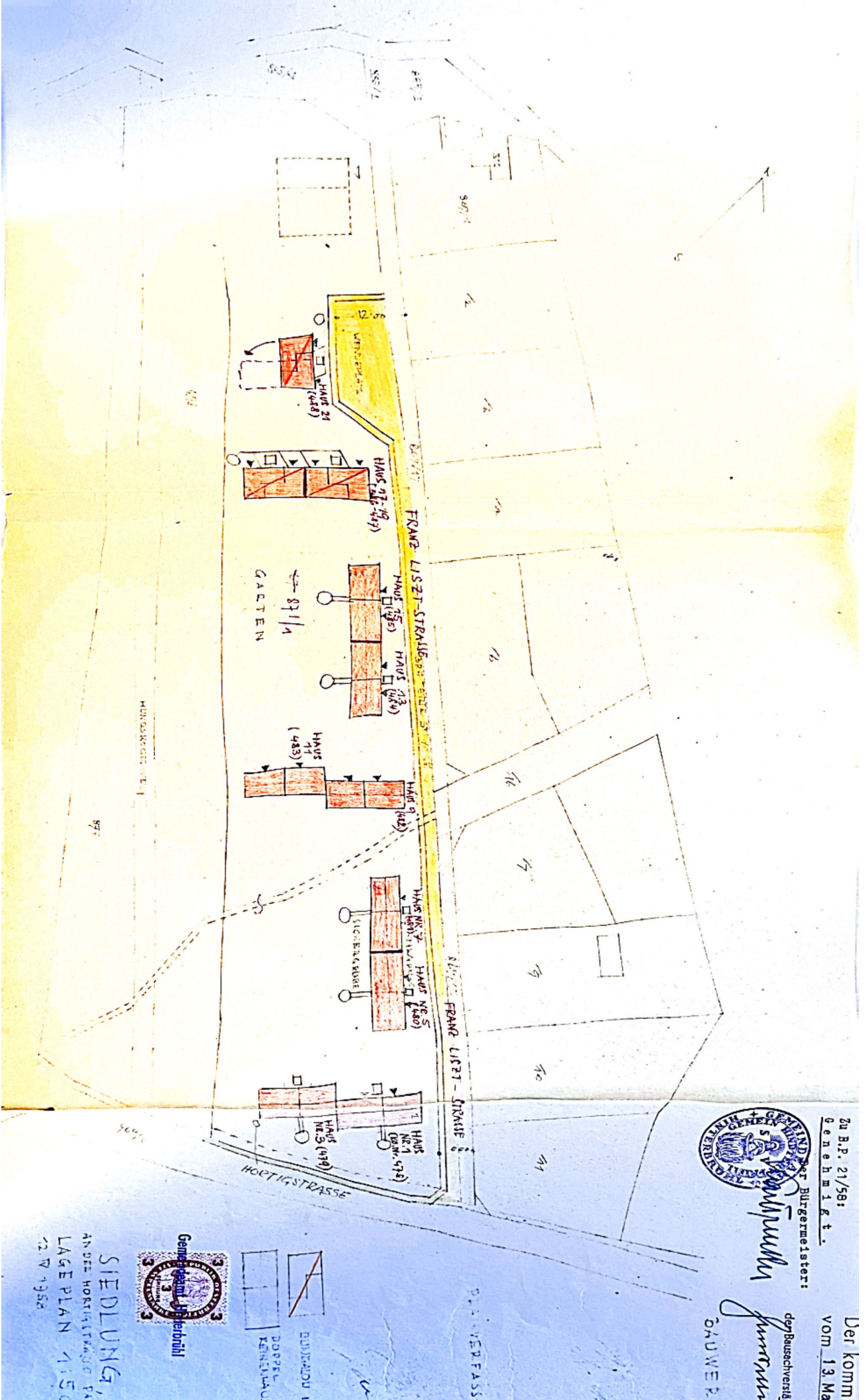
OBERGESSKUSSGRUNDRISS
